Image Use Terms of Agreement

The low-resolution images presented on this website are available as free copy/paste files for all researchers. These are intended for personal and scholarly purposes only. Individuals seeking commercial-quality, high-resolution images are required to order these through the Museum and pay any subsequent processing and use fees.

High-resolution digital copies of images from the Buffalo Bill Museum and Grave's photograph collection are available, unless restricted, for a fee based on the intended use of the photograph. Purchase/Use is subject to the following conditions:

1. Permission for reproduction is granted for one-time use only and does not apply to future reproductions or publications. Such subsequent use requires written permission and may require payment of additional fees.
2. Proper and full credit must be given. All reproduced photos must be credited as follows:
"Object ID# _____, Buffalo Bill Museum and Grave, Golden, Colorado." When known, proper credit must also be given to the photographer.
 - a. With printed material it is preferred that the credit line appears on the same or facing page of the photograph or with "Sources of Photographs" appendix. Each individual item must be credited.
 - b. With exhibitions, credit must be shown below the photograph or as part of the label copy in the exhibit area.
 - c. For film and/or video productions acknowledgment must be given as part of film credits.
3. Photographs of any of the materials in the collections of the Buffalo Bill Museum and Grave that will be used for any form of publication must be obtained from the Museum along with written permission from the Museum to use said photographs.
4. Commercial use of photographs is subject to additional fees and requires the written permission of the Buffalo Bill Museum and Grave. Permission for resale of images requires special permission and is done on a contractual basis.
5. Rights clearance and responsibility for copyright compliance is the responsibility of the requester/user.
6. The Buffalo Bill Museum and Grave reserves the right to limit the number of photographic copies; to restrict the use or reproduction of rare or valuable material; to ensure the reproductions and intended use are in good taste; and to make special quotations on materials involving unusual difficulty in copying.
7. A complimentary copy of any published work using a Museum photograph should be provided to the Buffalo Bill Museum and Grave.
8. Photographic images may not be altered in any way other than size without written permission from the Buffalo Bill Museum and Grave.
